I will provide proof of all booster vaccinations of my dog to Zipidy Do Dog Daycare LLC.

I understand that all dogs attending Zipidy Do Dog Daycare LLC must be spayed or neutered and at least six (6) months of age.

I understand all dogs attending Zipidy Do Dog Daycare LLS's program will be temperament tested. I hereby testify my dog does not have aggressive tendencies to other dogs or people, and all of my dog's history of bites or afflicting injury to any dog or person is disclosed to Zipidy Do Dog Daycare LLC in our application.

I understand that Zipidy Do Dog Daycare LLC is an environment where dogs will be socializing and interacting with people and other dogs of all sizes. As always, with the interactions of dogs, there is a chance of injury. Zipidy Do Dog Daycare LLC and all employees will supervise all dogs in the daycare environment but I understand at times, due to the inherent nature of dogs, there could always be a risk that my dog may receive or give bites, puncture wounds, scratches and scrapes that may result from the playful nature of my dog as well as other dogs enrolled in our daycare program. I also understand that typically the benefits of the socialization far out weight the risks. I agree to accept full responsibility, financially or otherwise, for any such injury or harm inflicted to my dog, or caused by my dog to any other dog or person while attending Zipidy Do Dog Daycare LLC's program.
